

Terms and Conditions

1. The Priceline Clubcard is issued by and remains the property of Priceline Pty Ltd. Priceline Pty Ltd reserves the right to withdraw the card at any time. **2.** Priceline reserves the right to alter or amend the conditions of operation of the Clubcard scheme, or terminate the scheme at any time. No alteration, amendment or termination of the scheme will affect any Discount Vouchers which have been issued at the time of any alteration, amendment or termination of the scheme. **3.** All participants in the Clubcard scheme must be resident in Australia. **4.** The Priceline Clubcard can be used at all Priceline and Priceline Pharmacy stores. **5.** Priceline Clubcard Points will be earned for purchases made at all Priceline and Priceline Pharmacy stores, excluding prescriptions and gift vouchers. **6.** The Priceline Clubcard cannot be used as a credit or guarantee card. **7.** To earn points for a transaction, the Clubcard must be presented at the register when requested, otherwise the transaction cannot be recorded and therefore points cannot be given. Points cannot be claimed retrospectively. **8.** A minimum of \$5 must be spent in a single transaction to qualify for Clubcard Points with one Clubcard Point being earned for every dollar spent. For the purpose of calculating the value of an individual purchase, Clubcard Points are displayed based on whole dollars paid, inclusive of GST. **9.** Collection periods are usually every calendar quarter (i.e., March, June, September, December) but may vary at Priceline's discretion. New dates will be advertised instore. **10.** Bonus Points will be offered from time to time during special promotions on selected merchandise and can be earned in addition to normal Clubcard Points. **11.** Rewards, in the form of Priceline Discount Vouchers, will be mailed with the points statement to customers who have accrued 100 Clubcard Points or more by the end of each collection period. **12.** Priceline Discount Vouchers can be used at any time and are not exchangeable for cash. **13.** The value of the Discount Voucher will be based on the total number of points a member has accrued by the end of the last day of a collection period including Clubcard Points and Bonus Points. For the purpose of calculating the value of a Discount Voucher, total expenditure for that collection period will be added and rounded down to the nearest dollar. **14.** The redemption value of points may be changed at the discretion of Priceline. Any change shall not affect points issued prior to the date of change. **15.** Each Priceline Discount Voucher will have printed on it the membership number of the member who earned the points. Priceline Discount Vouchers may only be redeemed on production of a Priceline Clubcard bearing the same Clubcard number as printed on the vouchers. **16.** The promoter of Priceline Clubcard is Priceline Pty Ltd which is also the owner of the scheme. Priceline Pty Ltd is located at 885 Mountain Highway, Bayswater, VIC 3153. **17.** If you are a Priceline Protects policy holder you will need to provide your policy number to receive Clubcard points on your premium
